The modern version of Mother's Day was first celebrated in 1907. Mother's Day is a celebration honoring the mother of the family and the influence of mothers in society. Anna Jarvis held a memorial for her mother at St. Andrew's Methodist Church in Grafton, West Virginia in 1907, after campaigning to make Mother's Day a recognized holiday in the United States beginning in 1905. Founder Jarvis regretted the current commercialism attached to Mother's Day as it was not her intention.

Lisa Armony is Chief Impact Officer and Director of the Rose Project of Jewish Federation of Orange County. In these capacities, she oversees grantmaking, leadership development and educational initiatives. She has worked extensively on Orange County college campuses, including for two years as interim Executive Director of Hillel Foundation of Orange County, to support Jewish life and on challenging issues of campus climate for Jewish students. As part of this work, she developed an experiential educational program that brings students to the Middle East to explore the Israeli-Palestinian conflict from diverse perspectives to diffuse tensions on campus and to promote dialogue and deeper learning. Now in its seventh year, the program has been scaled and runs on more than 60 campuses in North America.

A former professional journalist, Lisa has written for numerous trade journals, magazines, and newspapers. She holds a BA and graduated Magna cum Laude in Political Science from Cornell University and an MA from Yale University. She has also studied at Tel Aviv University's Moshe Dayan Center for Middle East Studies and earned a certificate in Israel experiential education from the iCenter and George Washington University. She is currently completing a dual master's degree in Jewish and Israel education from the Melton Centre for Jewish Education at The Hebrew University of Jerusalem and is a fellow in the Executive Leadership Program at the Mandel Institute for Nonprofit Leadership.



## Update on Covid-19, Testing, Vaccines & Vaccinations



**April 1, 2021, individuals age 50 and over are eligible to make an appointment.  
April 15, 2021, every Californian 16 and up are eligible for vaccination.**

**The FDA will authorize Pfizer's COVID-19 vaccine for 12-to-15-year-olds  
by the week of 5/10/2021.**

### Already vaccinated?

Keep track of your vaccination card.

Vaccination card may be needed for travel, business,  
and entrance into certain venues and locations.

1. Make a copy of your vaccination card to carry in your wallet.
2. Keep the original of your vaccination card with your other documents.
3. Take a picture of your vaccination card and save on your cell phone.
4. Send the picture of your vaccination card to your email address and save.
5. Notify your primary care physician of your vaccination.
6. Staples and Office Depot: will laminate proof of vaccination in-store for FREE.  
Staples service is available at all locations with no end date set.  
Office Depot service is available at Office Depot and Office Max locations  
through 7/25/21.
